HIGHER NATIONAL DIPLOMA IN SYARIAH CRIMINAL JUSTICE SYSTEM

The course commences with some historical perspectives of the Constitution of Brunei Darussalam. This is followed by the discussion on the conventional fundamental constitutional concepts; the Rule of Law; the Separation of Powers; the Royal Prerogative; and Sovereignty, with special focus of these concepts in the Bruneian constitution. The course will also discuss the structures and roles of the institutions of a State, including the Executive, Legislature and Judiciary, and the relationship between the individuals and the State, citizenship, immigration, and the State security. Some comparative aspects of constitutional law will also be covered, including Commonwealth constitutional relations.

It covers various topics, which relate to the actual administrative process of governmental bodies in discharging their administrative, discretionary, quasi-legislative and quasi-judicial powers. It also deals with what and how to control the administrative powers. Among the important topics, which this course covers are; constitutional foundation of the administration (constitutionalism and administrative apparatus), administrative discretion, administrative legislation, administrative adjudication, natural justice, judicial review and its limitation in Brunei, remedies, governmental liabilities, ombudsman, etc. Some Islamic inputs are also added, which includes the general concept of justice and public duties in Islam.

The course introduces the student to the nature, purpose and scope of criminal law. It will deal with the historical evolution of the Bruneian Penal Code; the general principles, elements and variations of criminal liability; the characteristics and features of the provisions in the Penal Code, their interpretation and construction. A comparative approach of the law of crime in Brunei, Malaysia, Singapore, India, Pakistan and England will be adopted, but with the emphasis on the penal provisions in the Bruneian context. Topics on 'General Exceptions, e.g. on mistake, accident, infancy, unsoundness of mind, duress, necessity, consent and right of private defense, will be studied. Topics on group liability based upon common intention and common object will also be included. General principles of criminal jurisdiction will also be covered.

SJ3307 FIQH OF CRIME

This course covers, among others, the concepts of crime and penalty and their types; criminal liability; crimes against religion (apostasy: definition, essential requirements, pillars, conditions and procedures of execution), life (homicide and injury: definition, essential requirements, pillars, conditions and procedures of execution), lineage (zina and *qadhf* (adultery and fornication and slander): definition, essential elements, conditions and procedures of execution), *shurb al-khamr* (drinking alcohol): definition, essential elements, conditions and procedures of execution; *sariqah* and *hirabah* (larceny and highway robbery): definition, essential elements, conditions and procedures of execution; and *qisas* and *diyah* (retaliation and blood money) as well as the role of judges in discretionary punishments (*ta'zir*). Some comparative aspects of constitutional law will also be covered, including Commonwealth constitutional relations.

It covers various topics, which relate to the actual administrative process of governmental bodies in discharging their administrative, discretionary, quasi-legislative and quasi-judicial powers. It also deals with what and how to control the administrative powers. Among the important topics, which this course covers are constitutional foundation of the administration (constitutionalism and administrative apparatus), administrative discretion, administrative legislation, administrative adjudication, natural justice, judicial review and its limitation in Brunei, remedies, governmental liabilities, ombudsman, etc. Some Islamic inputs are also added, which includes the general concept of justice and public duties in Islam.

LL2302 LAW OF TORT II

This course includes the nature and scope of damages available to victims of tortious acts of tortfeasors. It also covers intentional and non-intentional torts such as trespass to person and trespass to land, interference with goods, occupiers' liability, passing off, defamation, public and private nuisance, vicarious liability, and malicious prosecution. The available remedies under each tort are also dealt with respectively. The discussions will deal with relevant statutory provisions, wherever applicable, and case law authorities, including tort cases decided by the courts in Brunei Darussalam, with the emphasis on the interpretive role of the judiciary in dealing with the developments and changing scenario of this branch of the law.

LL2303 CRIMINAL LAW I

The course introduces the student to the nature, purpose and scope of criminal law. It will deal with the historical evolution of the Bruneian Penal Code; the general principles, elements and variations of criminal liability; the characteristics and features of the provisions in the Penal Code, their interpretation and construction. A comparative approach of the law of crime in Brunei, Malaysia, Singapore, India, Pakistan and England will be adopted, but with the emphasis on the penal provisions in the Bruneian context. Topics on 'General Exceptions, e.g. on mistake, accident, infancy, unsoundness of mind, duress, necessity, consent and right of private defense, will be studied. Topics on group liability based upon common intention and common object will also be included. General principles of criminal jurisdiction will also be covered.

LL3301 LAND LAW I

This course examines the foundations of legal knowledge in property law and the land law of Brunei Darussalam, namely the Land Code (Cap 40) and the Land Strata Act (Cap 189). It deals with the main characteristics and general features of the Torrens System of title in Brunei and its application through provisions of the Land Code. It also discusses the land law from historical context having its genesis in Islamic conceptions of landholding with general overtones of early Malay customary tenures.

This course covers the concepts of crime and penalty and their types; criminal liability; crimes against religion (apostasy: definition, essential requirements, pillars, conditions and procedures of execution); life (homicide and injury: definition, essential requirements, pillars, conditions and procedures of execution); lineage (zina and qadhf [adultery and fornication and slander]: definition, essential elements, conditions and procedures of execution); intellect (shurb al-khamr [drinking alcohol]: definition, essential elements, conditions and procedures of execution); wealth (sariqah and hirabah [larceny and highway robbery]: definition, essential elements, conditions and procedures of execution); and qisas and diyah (retaliation and blood money). The role of judges in discretionary punishments (ta'zir); and also, Principles of Islamic law of evidence to determine criminal offences in Islamic law and comparison of Syariah law and Brunei Penal Code.
